# VILLANOVA UNIVERSITY MEN'S BASKETBALL TEAM PRESENTED

The SPEAKER. Representative Bill Adolph and Representative Greg Vitali are invited to the rostrum for the purpose of presenting a citation to a certain championship team.

Chairman Bill Adolph, the floor is yours, sir.

Mr. ADOLPH. Thank you, Mr. Speaker.

This is my 28th year as a member of the House of Representatives, and I have witnessed an awful lot of celebrities, distinguished athletes, former Governors, Olympic champions. I had never witnessed the excitement of walking through the halls of this Capitol watching State Representatives, State Senators, staff, and fans want some piece of this basketball team. This team is a special, special group of young men, and just being around them, you can feel it. Everybody wants a part of this team.

I want to thank my colleague, Representative Greg Vitali, as we all know how dedicated he is on certain issues. The first time he ever got excited regarding an issue other than the environment was the day after Villanova won that championship. And Greg is such a dedicated public servant that he said to me, "Bill, would you please take the lead today? Because I have so many things going through my mind today regarding the environment, I need to get settled first."

Greg and I, for over 20 years, have shared the campus in one way or the other and the many students that have graduated. Greg, you will not believe this, was a football player at one time for Villanova. I tried to tell people that here and they do not believe it. He was a fierce football player for St. Joe's Prep. Where he went wrong, I do not know, but I had to thank him for allowing me to take the lead.

Behind me are Coach Jay Wright; team members Josh Hart, Darryl Reynolds, and Kris Jenkins. After finishing the regular season with an impressive 35-and-5 record and winning the Big East Championship, the Wildcats entered the NCAA (National Collegiate Athletic Association) tournament as a number two seed. From there Villanova beat UNC (University of North Carolina) Asheville, Iowa, Miami, Kansas, Oklahoma before taking down the University of North Carolina in the championship game. Throughout the tournament these players played with a grit and an intense willingness to help each other that allowed them to win this championship.

The Villanova community, the residents of Delaware County, the residents of the Commonwealth of Pennsylvania could not be prouder of this team's accomplishments. I think everybody 10, 15, 20 years from now will know exactly where they were when Kris Jenkins hit that shot. What a great moment.

I want to individually recognize the players and the staff on this team that are here today. Some of the seniors were not able to be here because they are throughout the nation trying out on various pro camps.

Here today with us are Josh Hart, Kris Jenkins, Darryl Reynolds, Mikal Bridges, Jalen Brunson, Tim Delaney, Donte DiVincenzo, and Eric Paschall. Fortunately, I did not have to pronounce Arci's last name.

Also with us, obviously, are head coach Jay Wright, Baker Dunleavy, Ashley Howard, Kyle Neptune, George Halcovage, Mike Nardi, Jeff Pierce, Mike Sheridan, Jake Whitten, and Arleshia Davidson. I would also like to thank some of the Villanova University administration who have joined us in the hall of the House.

You will never hear this from Coach Wright, but I would like to congratulate Coach on the recent news of being named an assistant coach on the USA Select Team that will practice for the USA National Men's Basketball Team next month in Vegas as it prepares for the Rio Olympics.

And excuse my personal touch. I would be remiss if I did not say to a good friend who passed away, who was a member of the 1971 Villanova Wildcats Team that went to the Final Four and I had known since I was 13 years old, Mike Daley, I am so proud to have the opportunity to bring your team to the State Capitol. Thank you.

The SPEAKER. Representative Vitali, the floor is yours, sir.

Mr. VITALI. Well, I also was one of those people who wanted a piece of Villanova. In fact, prior to the North Carolina game that morning, I drafted the cosponsorship memo honoring them for winning the national championship. That is how confident I was that they were going to win. I actually got a lot of flak for that as I was watching the game at the Great American Pub in Wayne that I had jinxed the team, but I was quite confident they were going to win that game.

I think that final game was probably the most thrilling basketball game I had ever seen, and I am proud, and I was

watching it with other Villanova alumni. I was undergrad class of '78 and law school class of '81, and I just cannot tell you how proud it made all of us to be Villanova.

But it was not really the fact that they won the national championship, which was an amazing feat in itself because these things are won every year by different teams; it was really how they won. It was really the professionalism, and not to use a pun, but the right way. You know, Jay Wright, he gets his kids with such a good attitude. When you read about what they do, it is not about winning a game; it is about being better than you were yesterday. That is what that program was about, just instilling those values, and you see how when they were playing – the tenacity, the fierceness, the fearlessness. I mean, it just really, really makes us all proud.

And it goes beyond just the enjoyment of watching a sporting event, because I saw what happened after 1985 and they won, and that helped enrollment for Villanova and how that made it a better school. Well, this is really making Villanova a better school in terms of quality of education, quality of professorships, quality of the student body. It is really making us proud.

But I think, I think the kids, you guys, really need to know the role model you have been to all of us. You are kids who are 4-year athletes, you are not one and done; you are 4-year athletes. You are scholar athletes, and you really are – people, not only basketball players but others, can really emulate as to how people should conduct their lives.

So you all have a lot to be proud of, and thank you for letting me be a part of it. Thank you.

The SPEAKER. Coach Wright, the floor is yours, sir.

Mr. WRIGHT. Thank you.

It is a true honor for us to be here in this beautiful building today. As a native Pennsylvanian, I am embarrassed to say this is the first time I have ever been here, and this is a remarkable building with men and women who serve our State, and it is a great experience for our guys to meet all of you and meet great men and women that use their lives to serve their State. We talk to our guys about this all the time. It is about what you do with your life after basketball that is most important, and we are most proud that we have a 100-percent graduation rate and that these guys, all of these guys that are administrators here – and there is a big part of the Villanova family that is here today – we are very honored, but everyone at Villanova takes pride in what these guys do with their lives, and that is what we are most proud of. And they are processed to be the best men they can be, the best students they can be, and the best players they can be, turned into a championship. So that is what we are proud of.

We were able to present the chairman with a ball signed from the team, a Final Four ball, earlier in his office, which is very impressive, and we would like to present a Villanova alum, Representative Vitali, with a ball signed by our team, a Final Four basketball.

Thank you for having us all today, and thank you for what you do for our great State.

The SPEAKER. Coach Wright, to you and your players, you are such a classy team representing such an outstanding university, and I just want you to all know that all of us felt like we were Villanova graduates on that championship victory night, all of us did.

Thank you for coming to see us here today. We are so honored by your presence. To all of these fine, fine young men and their coaches, thank you so much.

If the other Villanova teammates could come up to the rostrum, please. If the other Villanova players could come up to the rostrum, please; just come on up. Thank you.

They are on the forefront of all the guests that come to Pennsylvania. Their perception of us, of Pennsylvania, many times is determined by their experience at one of our parks.

Now, joining me today, with members here – Representatives Masser, Mackenzie, and Ward – we have the four guests here today. But all of us and all of you who represent Pennsylvania know somebody that works for an amusement park and clearly know that these parks are a great gift to Pennsylvania. They are unique. Some of our parks are over 100 years old.

Mr. Speaker, I thank you for allowing us to run the resolution today. I am hoping in the future other members pick up and run this every year recognizing the second largest industry, tourism, and the vital role that the amusement parks play in that second largest industry. And I would also like to thank my colleagues behind me for their outstanding support and supporting their amusement parks back home.

I would like to ask for one last round of applause for all the amusement parks and the guests that are here today. Thank you, Mr. Speaker.

Mr. Speaker, that is why it is so important that our House of Representatives has designated June 2016 as "Cancer Survivors Recognition Month" here in the Commonwealth of Pennsylvania. In passing this resolution, we are celebrating life.

I thank my colleagues for supporting this measure as a way of honoring all cancer survivors and their families and paying tribute to the strength, courage, and inspiration of those living with a history of cancer.
