It was with those comments in mind as I was sitting at the BBQ watching the event, I was struck by the work of one of our Directors. I realized the need to talk about Jerry Ellis. Jerry has been through many Presidents while being the Treasurer, Billy & Spanner Editor, Director of Membership and other positions long before I joined the Association. He has kept consistency in the Association's mission and methods to achieve success for all retirees. Here is what Jerry did for this last event. Prior to the BBQ, Jerry maintained the sign-up count for the meals, kept track of who paid, constructed/updated the VIP list and sent out VIP invitations. At the August Association Board of Directors meeting, I asked the Board to answer the question which several members have asked in the last two years. The question is "What has the Association done for its members in advancing or maintaining our retirement benefits?" The Board produced a long list of points which I will share with you in next month's Billy & Spanner.

This month I am formally notifying all Association members, per the vote which was taken by mail in early 2012 of increasing the Association dues from \$15 to \$43 for one year to fund the Legal Fund. This increase will commence in January 2014. Those Association members who contributed early to the Legal Fund will have their contributions returned after April of 2014. In this way, all members of the Association will have an equal contribution in what the Association sees as a long legal battle after the Measure B court decision is rendered. Another reminder that nominations for Association Officers and Board of Directors' positions is coming up in October. A key officer position, Secretary, will be vacant as long-time Secretary Jerry Boyer will not be running for re-election.

As we continue through this tumultuous time for the Association caused by City leaders, we need members to step forward to help lead this organization over the next few critical years.

Nomination of officers is held in October at a regular membership meeting (Oct. 10th) and the election will be held at our November membership meeting (November 14th). If you are interested in running for Secretary or any other office, you must be present at the October meeting or provide a letter of intent to the Secretary before the October meeting is held.

Measure B Lawsuit in Judge's Hands

In our last newsletter, we informed you that the Measure B pension trail would begin soon. The trial has officially concluded and is in the judge's hands now. In terms of next steps, a ruling is anticipated sometime this fall. It is almost certain that regardless of the decision, the losing side will appeal the ruling to the Court of Appeals. As such, we are not likely to see this issue resolved for a few more years. In the meantime, the City will continue to spend millions of dollars on their outside legal team and our Police & Fire Departments will continue to struggle to recruit and retain quality employees. The staffing problems on the Police side have hit crisis levels, with the department having well under 1,000 officers on the street. This problem is not likely to be addressed until the Measure B fiasco is cleaned up.

AUTOMATIC DEDUCTION ELECTION FORM: MEMBERSHIP DUES IN THE ASSOCIATION OF RETIRED SAN JOSE POLICE OFFICERS & FIREFIGHTERS

I, ______hereby AUTHORIZE the Department of Retirement Services to deduct my monthly membership dues to the Association of Retired San Jose Police Officers & Firefighters ("Retiree Association") each month from my retirement allowance, in the amount that is approved from time to time by the Retiree Association, and to send the amount so deducted directly to the Retiree Association on my behalf. I understand that the current membership dues are \$15 per month, but I understand and agree that the membership dues may be increased or decreased later, in accordance with the Retiree Association's rules. I agree that if the Retiree Association's monthly membership dues change, that change will automatically apply to the monthly dues deduction from my monthly retirement allowance. The dues will be sent directly to the Retiree Association in my name.

I further AUTHORIZE the Department of Retirement Services to provide the Retiree Association with my mailing address currently on file with the Department of Retirement Services and to update the Retiree Association with any changes that might later be made to my mailing address on file with the Department of Retirement Services.

I UNDERSTAND THAT I MAY CANCEL AND REVOKE THESE AUTHORIZATIONS AT ANY TIME BY DELIVERING A WRITTEN NOTICE OF CANCELLATION AND REVOCATION TO THE DEPARTMENT OF RETIREMENT SERVICES AT LEAST 20 DAYS BEFORE MY NEXT SCHEDULED RETIREMENT ALLOWANCE PAYMENT.
