# Precision Industry Series – Transformative Technology for Media & Entertainment

## **TERMS AND CONDITIONS**

- The Promoter of the Dell Technologies Precision Industry Series for Media & Entertainment Competition (the Competition) is Dell Global B.V. (Singapore Branch) (a member of Dell Technologies) (the Promoter).
- 2. Entry into the Competition constitutes acceptance of these Terms and Conditions and Dell's Privacy Policy. All entry instructions and prize information published by the Promoter also form part of these terms and conditions.

## **COMPETITION DATES**

- 3. The Competition period commences from 1:00 pm SGT on December 8, 2022 to 2:30 pm SGT on December 8, 2022 (Eligibility Period).
- 4. Entry in the Competition is free and entries must be completed within the Competition Period. The Competition is open to individuals who meet the Eligibility Criteria (Eligible Entrants).
- 5. Participants must further meet the following criteria (Eligibility Criteria):-
  - a) Must be a Citizen / Permanent resident of any APAC eligible countries, which are: Indonesia, Malaysia, Philippines, Singapore, Thailand, Afghanistan, Bangladesh, Bhutan, Brunei, Cambodia, Fiji, Laos, Maldives, Mongolia, Myanmar, Nepal, Pakistan, Papua New Guinea, Samoa, Sri Lanka, Vietnam, Australia, New Zealand, India;

- b) Survey Form contest:
  - i. Eligible Entrants need to fill and complete the survey form during the Competition Period.
  - ii. The Eligible Entrant must also provide a response to question *"What new technology has your organization adopted to optimize your workflows?"* ("Competition Question")
- 8. Each Eligible Entrant may only submit one Prize Entry. Any additional Prize Entries submitted after the first valid Prize Entry received by the Promoter will be invalid.
- 9. The Promoter takes no responsibility for late or misdirected online registration forms or any delays or failures in any telecommunications services or equipment. Online registration forms will be deemed to be accepted at the time of receipt by the Promoter and not at the time of transmission. The Promoter accepts no responsibility for late, lost or misdirected online registration forms. Incomplete, inaccurate, erroneous, ineligible or incomprehensive Registration Forms will be deemed invalid.

### **JUDGING & PRIZE DRAW**

### a) Quiz Leaderboard contest:

- I. Answering the questions in the Quiz Leaderboard contest correctly in the least amount of time.
- II. The score for each question is automatically calculated and is based on whether the answer is correct and the time it took for the correct answer to be entered by the Entrants. There is no random selection of entries.
- III. At the conclusion of the Quiz Leaderboard contest, the highest scores will appear on the poll. The highest scores represent the potential top ten (10) winners.
- IV. Judging of the competition will take place on 2:30pm SGT on Thursday, 8 Dec, 2022

### b) Survey Form contest:

- I. The Eligible Entrant must successfully complete the questions in the survey form and provide a response to the Competition Question.
- II. The five (5) winners will be selected based on the completion of the survey and the most original or creative submission of the Competition Question.
