In its report to the Senate and Assembly the Committee on Unsatisfied Judgments held that an insurance system proposed by insurance companies was not "an adequate or equitable" solution to the problem posed by the uninsured driver.

The committee, headed by Senator William S. Hults Jr., Nassau County Republican, called Mr. Dewey's plan the "only simple, logical and permanent solution" to the problem.

It also recommended that the Legislature adopt an "assigned case" plan to protect motorists who suffer injury or damage in accidents with hit-run drivers, uninsured motorists from outside the state or drivers who fail to meet compulsory coverage requirements.

Mr. Dewey has predicted his compulsory plan will be approved. Last year a similar proposal died in committee.

The committee made its report public yesterday.

Safeguards Added

Under the administration proposal, a motorist, when applying for a registration, would have to supply proof that he had insurance or other means of paying for damage resulting from his negligence.

Mr. Hults said adoption of the plan would cut "to a fraction of 1 per cent the accidents involving uninsured motorists."

The assigned case plan would provide for designation of an insurance company to handle all injury and property damage claims in excess of \$100 against uninsured drivers in the same manner it would if the motorists were insured.

Losses and expenses would be divided among all insurance companies licensed to write auto liability insurance in the state. The plan was proposed by Mr. Hults and Assemblyman Angelo Graci, Queens Republican.

Deductible Clause Hit

The committee criticized the insurance companies' voluntary plan on the grounds it would not provide protection against hit-run cars, would exclude anyone covered by workmen's compensation and had a \$300 deductible clause. That last item, the committee said, would eliminate about 85 per cent of property damage claims and about 62 per cent of all injury claims.

Under the voluntary plan all insured drivers would pay about 2 per cent additional on their liability premiums for protection against uninsured drivers. Mr. Hults maintained that would cost insured drivers an extra \$6 million a year.

SULLIVAN, Ind. (AP)—Will H. Hays, seventy-four, who led a predepression cleanup of movie morals after uniting the Republic Party behind President Harding, died in his home yesterday. He served 24 years as special czar of the motion picture industry. He was Republican National Chairman before he was forty. His wife Jessie and his only son, by a former marriage, Will H. Hays Jr. of Crawfordsville, Ind., were at his deathbed.

Mr. Hays brought a landslide victory for President Harding in 1920, and Mr. Harding named him postmaster general.
