

## Contest Terms & Conditions

1. The Organizer and the right to participate in the contest. The Organizer of the Contest is Express Publishing S.A., with registered offices at 25 Gardenias Street, 136 78, Athens, Greece. All natural persons who have reached the age of 18 or the corresponding age limit depending on the jurisdiction to which they belong, and have legal capacity may be eligible for participation in the Contest. People below 18 years old or the corresponding age limit depending on the jurisdiction to which they belong are not allowed to participate in the Contest.
2. Non-eligibility for participation. The employees of the organising company are not entitled to participate in the contest.
3. Venue and duration of the contest. The contest will take place through the Organizer's website and eshop at [www.expresspublishing.co.uk](http://www.expresspublishing.co.uk) for orders placed by individuals (B2C) from **30/11/2021 00:00 Central European Time until 07/01/2022 23:59 Central European Time**.
4. How to participate in the contest. During the duration of the Contest **from 30/11/2021 00:00 Central European Time until 07/01/2022 23:59 Central European Time**.  
any individual can participate in the contest simply by submitting and completing an order of any products through the website of the Organizer at <https://www.expresspublishing.co.uk>, of a minimum total value of fifty (50.00) Euro, and by entering the coupon code '**LuckyPolarExpress**' in the special box when placing the order, which (code) provides at the same time a discount of ten percent (10%) on the total value of the order. It is clarified that the participation in the contest will be considered valid only if it concerns the ordering of products of an initial (before the use of the '**LuckyPolarExpress**' coupon code) a minimum value of fifty (50.00) euro and if it has been submitted (the order) definitively during the period for which the tender is valid, at all times on the condition that the participant will not exercise the right to withdraw from the contract by returning part or the total of their order and request the return of the order's value to them. The participation of each individual will be counted based on the order code he will receive after the final submission of his order as per above. According to the above instructions, each individual will be entitled to one entry per order, while the submission of more orders will correspond to a corresponding number of entries in the tender. A necessary condition for the validity of each entry is the completion of all the necessary personal data (name, address, postcode, e-mail address, telephone), the use of the coupon code '**LuckyPolarExpress**' in the special box during the submission of the order, as well as the acceptance of the present terms of the Contest.
5. The Organizer is entitled to verify the validity of the participations, and disqualify any participant who violates the contest terms herein.
6. The winner will be selected from the "valid participants". A "valid participant" is any participant who has submitted an entry in compliance with Terms 4 above.
7. Selection of winner. The Organizer will place the special card '**Lucky Polar Express**' in five (5) of the orders that will be submitted by the participants and then will be executed at the facilities of the Organizer during the Contest. The selection of the five (5) orders will be done in a random way and the winners of the Contest will be selected in this way randomly, is those who find the special card '**Lucky Polar Express**' in the package with the items of their order, as it will be sent to them by the Organizer, will be the winners of the Contest.

informing about their selection and attaching a photo with the special card "**Lucky Polar Express**", with the code written on it, in order to confirm their selection and their personal details and then be sent their gift. 10. The organizer's responsibility. The organizer's only responsibility is to offer the prizes, as described herein. The Organizer is not responsible for any faulty services provided by a third party, or for any harm sustained by anyone who uses the prize, or receives services associated with the prize; also, the Organizer does not promise or guarantee that a third party will fulfil their responsibilities as to the aforementioned prize.
12. The prize will be offered and delivered on account of the contest, excluding the implementation of any ordinances regarding the seller's liability, or the organizer's liability for any real defects on the prizes, etc. In any case, the organizer's responsibility is restricted to actions or oversights caused by willful misconduct or criminal negligence, and is not extended to accidental events or those resulting from force majeure.
13. Publicity. The contest terms and conditions will be available at the organizer's official website.
14. Personal data. The participation of all adults and minors, with the consent of their parents or guardians, entails that they implicitly agree to their personal data being processed and used, so that the Organizer will compile personal data files so as to conduct and monitor the contest, according to the organizer's Personal Data Protection Policy. Furthermore, the Organizer is entitled to make use of the winners' minimum required data for its website, or for any promotional activity in connection with the contest, such as, for example, posting the winners' names on the organizer's

accounts in the social media. The Organizer is allowed to use the database, compiled during this contest, for advertising purposes, and promotion of its services, only on condition that the participants have consented to this explicitly, when submitting their entries and personal details. The Organizer will process the archive in order to conduct the contest, and will keep the participants' personal details on its database. The purpose of the file compilation is to select the winners of the contest and run the aforementioned campaign. Within 6 months of the grant of the awards, any personal data of Participants and Winners of the Contest will be destroyed unless their preservation is justified or required by applicable law. 17. Applicable law – jurisdiction. The aforementioned terms are subject to and supplemented by the Greek law. Any dispute that may arise in the future in connection with this contest is to be resolved exclusively by the courts of Athens.
18. Acceptance of the terms. Participating in the contest entails implicitly acceptance of all the aforementioned terms, as well as the concomitant waiver on behalf of the participants of any claim against the Organizer.
