Third, in Section 10., for those in North America, please affix USPS Priority Postal Stamp* in the lower right-hand corner. For those outside of North America, please affix postage/stamp* issued by that country's Post **Each form is a financing*

statement to transfer LIMITED assets from the association to its associates. The priority postage stamp enables the conveyance by settling associate's (a.k.a. Assignee on form) portion of the tax on legal documents.

Fourth, include Ten Dollars and No/100 Cents (10.00) in equivalent U.S. Dollars (money order or personal check) and made payable to:

4. Deliver form and payment to Oklahoma County (see above for address).
