5. What did the organisation say?

Our correspondence with Defra's Head of Information Standards and his response to our complaint is attached. It states:

- 1. "no notes, minutes, action points exist" of a telephone conversation which took place between the ABC and Defra's Agri-tech Strategy team on 10th June 2013. We continue to find this response surprising and would like access to the outcomes of this discussion.
- 2. The "15 April 2013 email from ABC Message on media suggestions" was sent us us in error and therefore we are not entitled to a review of whether the redactions meet the public interest test. We disagree with this finding and maintain our view that only the names should have been redacted.
- 3. In the "8 February 2013 email to GM team from Monsanto" an attachment or other information (referred to "as discussed") appears to have been omitted, as does any follow-on to this discussion. We are not satisfied with Defra's response that no further information exists.
- 4. Defra confirms the meeting Lord de Maulev was offering the ABC was never set up. Yet it is silent on the meeting between the ABC and the Rt Hon David Heath MP (then Minister of State) which took place in January 2013 "To discuss role of agri-biotech including GM, in the UK and particularly food security and economic opportunities" (according to Defra's ministerial meetings list which has now been published on: https://www.gov.uk/government/uploads/system/uploads/attachme nt data/file/212312/defra-min-transparency-1213-q4.pdf). Not only did Defra not reveal this meeting to us in response to our original request it now states: "An email origination [sic] from Assistant Private Secretary to David Heath and circulated to a number of Defra officials was withheld under regulation 12(4)(e) of the EIRs. Also withheld under the same regulation was an email circulated internally about a meeting with Agricultural Biotechnology Council - Summary and Questions". We do not accept that the public interest test has been applied correctly in this case and request access to both these documents.

Government discussions with the biotech industry regarding genetically modified crops and foods raise issues of significant public interest, including environmental protection. GeneWatch UK therefore continues to believe that these documents should not be withheld.

Finally, although Defra has apologised for the substantial delay in handling both our original request and our compliant, we remain concerned that the effect of this delay has been to hide important conflicts-of-interest and corporate influence on environmental policy from public scrutiny and debate.
