

Parental Survey responses.

Thank you to all parents who submitted a response to the parental survey from last term. As you can see from the result of the survey the overwhelming majority of parents and carers feel the school is doing all it can to ensure the children and adults are safe and well looked after when on site. (5 indicates strongly agree with the statement, 1 indicates strongly disagree with the statement).



Remote Learning in the event of children isolating or class bubble closures

Following the survey, we have refined our remote learning plan which we will use from this term onwards to support staff in planning for and delivering remote learning and to help parents to understand the requirements in the event we have to work remotely.

At the risk of sounding like Boris(!), we have drafted a 4 Tier plan for remote learning delivery based on several different factors:

Tier 1 - Self Isolating or waiting for test result - up to 14 days.Tier 2 - Shielding for a length of time (lo than 14 days)		Tier 4 – Local/National Lockdown – whole school closed.

In all Tiers, all children will have a Google Login and work will be uploaded to Google Classroom (Tapestry for Reception). Children unable to access online learning will be provided with paper learning packs for the duration of the isolation.

Specific requirements of each Tier:

Tier 1 – Self Isolating or waiting for test result – up to 14 days.

In the event of self-isolation – including staff – the following will be provided either by the class teacher or cover (SLT):

- Weekly learning will be set. (English, Maths and one topic area)
- Specific feedback will not be provided as the class teacher will be responsible for maintaining their classroom responsibilities but the class teacher will acknowledge the work has been 'handed in'

Weekly learning may take the form of:

- Mathletics/Maths Seeds activities
- Accelerated Reader tasks
- Worksheets or online tasks
- Oak Learning Academy or BBC Bitesize or any other online teaching websites
- Learning which is not 'online' such as art activities, writing tasks, outdoor learning (in your own garden)

In the event the class teacher is isolating and not ill they will provide pre-recorded lessons/ instructions for the class to access or any children also isolating.

Tier 2 – Shielding for a length of time (longer than 14 days)

In the event of isolation – including staff – the following will be provided either by the class teacher or cover (SLT):

- Weekly learning will be set. (English, Maths and one topic area)
- Feedback will be provided weekly on the child's learning and the class teacher will acknowledge the work has been 'handed in'
- The class teacher or other adult will check in with child once a week via Zoom or telephone in liaison with the parents

Weekly learning may take the form of:

- Mathletics/Maths Seeds activities
- Maths No Problem/ White Rose Maths lessons
- Reading comprehension lessons
- Accelerated Reader tasks
- Oak Learning Academy or BBC Bitesize or any other online teaching websites
- Learning which is not 'online' such as art activities, writing tasks, outdoor learning (in your own garden

In the event the class teacher is isolating and not ill they will provide pre-recorded lessons/ instructions for the class to access or any children also isolating.

In both Tier 3 and 4 situations class teachers will provide an overview of learning being set for the following week. This will enable parents to have an overview of each day and what to expect.

When providing remote learning in Tier 3 and 4, class teachers will be 'online' between 9.00am and 3.00pm and be available to provide feedback at an agreed time with their class (for example at the end of a morning session and at the end of the afternoon session).

At present, we have no plans to move to teaching via live lessons in Tier 3 or 4 but this is something we are considering for the future.

As with all things at the moment, please bear with us as we introduce any new ways of working. There may be teething problems at the start and we may have to adapt or change any arrangements as we move further through the year.

We also understand the huge pressures families are under at the moment and as long as we keep communication open between home and school, we will support you in whatever way we can. Our children, their safety, their health and their education is the most important thing to us all, and by working together we will get through this together.

Parent Consultation Meetings

Our next Parent meetings are scheduled for Term 4 and the plan will be to hold them as face to face meetings if appropriate and safe by that time. If this is not possible, we will resume the online meetings. Further details will follow nearer the time.

Foodbank collections

year. We were overwhelmed with the number of carrier bags we were able to fill with donations which have been gratefully received by those who need it the most. Thank you.

We are working with the Foodbank in the next few weeks to support families as we approach the Christmas period. We would like all classes to collect food and donations to make up some special Christmas hampers which can be delivered to families who need support at this time. Daily Mile

This term we are trying something a bit different with our daily mile walking. Children in Year 5 and 6 will be completing their daily mile every day by walking up to and around the Paddock in the village.



As the children will be walking on grass for some of their mile, please can you supply your child with a pair of wellies or shoes and socks they don't mind getting muddy. This will avoid a trail of mud coming back into the school upon their return!

If this proves successful we will be extending this to Children in Year 3 and 4 next term.

Remembrance Day 2020

We would normally hold a special remembrance service in school where the whole school community would come together to think about



what it means to remember those who have fallen in conflict.

This year however, we will be holding a virtual service in classrooms and children will be asked to take part in a 2 minute silence within their bubble.

We will be selling poppies and other Remembrance Day merchandise to raise money for The Royal British Legion. Each class has been given a selection of items to buy from. Please consider donating to this very important charity.



Assessments

Towards the end of last term and at the start of this term the teachers will be working with children on some assessments of their learning in order for us to determine where any gaps have appeared as a result of the lockdown in March and what steps are needed to support them in the coming months. Please do not be alarmed if your child is coming



home saying 'we've been testing all day today!' Many of the assessments involve practical or informal questions and are part of our usual teaching and learning and follow closely the schemes of work we use.

It is still the Government plan to continue with statutory assessments this academic year so children in EYFS, Year 1, Year 2, Year 4 and Year 6 will be working towards their end of Key Stage assessments, the phonics screening check and the Times Tables check. Parents and Carers of children in those year groups will be kept informed of progress and how they can best support from home.

Welcome!

We are pleased to be able to welcome back Mrs Mace to the Holywell Team. Mrs Mace has returned to the school after taking some time out to look after her family.



She will be working in KS1 initially supporting some catch up learning for children who need additional support with reading and phonics.

Looking ahead...

KS1 Nativity and KS2 Carol Service

It will not be possible this year to hold a KS1 Nativity or KS2 Carol Service in the same way we have done in previous years. This is a real shame as it is one



of the many events at the school we look forward to each year so we have been looking at an alternative option.

We have consulted with other schools and plan to have a virtual Nativity and a virtual Carol Service. We will film the children in their bubbles performing songs, dances, readings or prayers and will then upload this to Google Classroom for Parents and Carers to view at home.

We understand not all parents will feel comfortable with this format so we will be seeking parental consent before filming. Further details of this will follow nearer the time.

Updated COVID-19 guidance following the announcement of a new National Lockdown

The situation across England is clearly changing on a daily basis and we all have a duty to ensure this is followed for the best interests of our community and families.

The Prime Minister set out four key preventative measures we are all asked to follow. These are:

- 1. Wash your hands, regularly and for 20 seconds.
- 2. Wear a face covering over your mouth and nose if you are in an enclosed space and in close contact with people you don't normally meet.
- Make space. Always stay 2 metres away from people you don't live with – or 1 metre with extra precautions, like extra ventilation, screens, or face coverings.
- 4. If you have COVID symptoms, get a test and self-isolate.

What has changed?

The most important changes from Thursday 5th November:

- 1. Stay at home except for specific purposes
- 2. Avoid meeting people you do not live with unless for specific purposes
- 3. Closure of business and venues

The new measures will be in place until 2nd December and will be underpinned by law.

How we can all support one another

In order to help everyone to keep safe at Holywell and in our community, please can you ensure:

- Your child **does not attend** school if they have COVID-19 symptoms or have tested positive in the last 10 days.
- You follow the 'stay at home: guidance for households with possible or confirmed coronavirus (COVID-19) infection' which sets out that individuals should self isolate for at least 10 days and should arrange to have a test. https://www.gov.uk/government/publications/covid-19-stay-at-home-guidance/stay-at-home-guidance-for-households-with-possible-coronavirus-covid-19-infection
- Members of your household (including any siblings) **self isolate for 14 da**ys from when the symptomatic person first had symptoms
- Avoid congregating in groups outside the school gates.
- Forming support bubbles with only one other household for drop off and pick up times for your child
- Encouragement to wear face coverings when entering the school grounds, especially at busy times such as drop off or pick up times

Suspected or confirmed cases of COVID-19

The most important preventative measure is to ensure everyone within the school community understands what to do if someone becomes ill with COVID-19 symptoms. May I remind you the symptoms are:

- a new, continuous cough or
- a high temperature **or**
- loss of, or change in, normal sense of taste or smell



If you, your child or anyone else living in your household becomes unwell with symptoms of COVID-19 **you must**: Follow 'stay at home: guidance for households with possible or confirmed coronavirus (COVID-19) infection'

- Self isolate for 10 days
- Arrange a test
- Other members of the household to self isolate for 14 days from the date the symptomatic person first had symptoms

For anyone who becomes ill while in school we will follow our existing guidelines and isolate that person until they can be collected and taken home. If your child becomes ill only someone who lives in the same household will be able to collect from school.

Arranging a COVID-19 test

Parents and staff will be informed they are expected to engage in the NHS Test and Trace process if required to do so. They will be required to book a test and provide details of anyone they have been in close contact with. The school have been provided with a small number of home testing kits for any families unable to go to a test centre.

If you are unable to attend a test centre, you can order a home kit which will be posted directly to you. Please see this video for how to conduct a home test:

Please note, the school may be required to share pupil/parent contact information with public health officials. This sharing of information is permissible under current law and is in line with data protection guidance covering schools.

If the test is negative the child can return to the setting assuming they are well enough. If the test is positive, all children and adults within that group should follow the 'stay at home' guidance and self isolate. This is why it is so important to not mix with other children and adults outside of your group – it is a protective mechanism.

We may be required to close the bubble temporarily until the results of the test have been given. The school will liaise with the Kent Health Protection Team for further guidance.

In the event of a bubble closure or a school closure we will continue to provide home learning through Google Classroom.
